DETERMINATION LETTER

Chair Gary Woodward read the Determination Letter in accordance with Utah Code 52-4-207(4) of the Utah Open and Public Meeting Act that states according to the COVID-19 pandemic, the meeting may be held electronically.

ARBOR DAY

Chair Gary Woodward contacted Mayor Wilkinson about signing the Arbor Day Proclamation 2021-01 declaring May 2021 as Arbor Month in Centerville. Mayor Wilkinson agreed to sign the proclamation when he returns on April 26th.

SELF-GUIDED TREE TOUR

Scott Zeidler reported shortly after the March meeting, he talked with Mike Smith, GIS Specialist, who said he can make a list for a self-guided tree tour, and a tree map of where the trees are located in Centerville. Mr. Zeidler recently collected photographs of trees from the Centerville cemetery, parks, and City Hall. He sent an email to Tree Board members prior to this meeting with an Excel spreadsheet of the trees located on public properties. There are also trees he gathered information from that are on private properties, and he will get verbal approval from the property owners to have these trees on the Tree Board website.

Jennifer Hansen, Deputy Recording Secretary, will add the Arbor Month Declaration and link to the tree list on the City webpage. A link to the tree map for the Centerville Self-Guided Tree Tour will be on social media with a brief description of each tree. Gary Smith will write the description of each tree for the link, and for the flyer that will be made.

PARK STRIP TREES IN THE CITY ORDINANCE

Chair Gary Woodward reported the park strip trees and other tree planting and care suggestions have been posted on the Tree Board webpage. Gary Woodward reported he has tried to contact Tree City USA on park strip trees, but they have not returned his email. He suggested their website link be posted on the Tree Board website for residents to access on their own. Chair Woodward will verify with the City Attorney if this is legal without contacting Tree City USA for their permission to post the link. Jennifer Hansen will do a tree logo on the links.

MISCELLANEOUS

Chair Gary Woodward reported he will continue to try and contact Bill Ince, City Council Liaison, regarding the update to the City Tree Ordinance to add new trees.

Scott Zeidler reported Diamond Tree Care has been clearing invasive trees on the east side of the Frontage Road in the pond area, and they also thinned the remaining trees. He also reported there are trees in Centerville that have been damaged by the recent winds and the east wind from last September. The Tree Board can promote caring for damaged trees.

Joy Chambers said she would like to have a container with tree stickers for children who come to City Hall. This will help children gain an awareness of trees. Chair Gary Woodward said he will ask for permission for the tree stickers to be placed at City Hall.

MINUTES REVIEW AND APPROVAL

Minutes of the March 17, 2021 meeting were reviewed. Gary Smith made a **motion** to approve the March 17, 2021 minutes as written. Grant Chavez seconded the motion, which was passed by unanimous vote (5-0).
